## 247 students graduate at XISS's 63rd Annual Convocation

## International Seminar on 'Revisiting Rohtasgarh': Cultural Adaptation & Storytelling: The Formation of Adivasi Literature

XISS, Ranchi under its Dr K S Singh Tribal Resource Centre (DKSSTR), Department of Research & Planning & Rural Management Programme and Ms Mary Girard, a US Fulbright-Nehru Researcher at Jawaharlal Nehru University (JNU), Delhi jointly organised a two-day International Seminar on the topic 'Revisiting Rohtasgarh': Cultural Adaptation & Storytelling: The Formation of Adivasi Literature on 17-18 June 2024 at the Fr Michael Van den Bogaert SJ Auditorium, XISS Ranchi.

This seminar marked a significant milestone in the exploration of Adivasi cultures and their literary heritage. As it offered a comprehensive and insightful examination of the intricate relationship between culture, adaptation, and storytelling.



Revisiting Rohtasgarh Workshop

The welcome remarks were given by Director, XISS where he mentioned that, this centre established with a vision to bridge academic excellence with societal impact, embodies our dedication to understanding and advocating for the rights and development of tribal populations across the nation. ## Sampark embarks its fourth phase

Following the successful and impactful implementation of three prior phases of Sampark, the collaborative partnership between XISS and UNICEF, Jharkhand, embarked on a new endeavour with the fourth phase of the programme. This phase focuses on Child Protection. The programme titled "Strengthening convergence and child protection mechanisms for reducing harmful social norms of child marriage and violence against children and women in select districts of Jharkhand" began on April 1, 2024. The programme is headed by Dr Anant Kumar and led at the state level by Mr Aditya Raj.

The Sampark IV project provides technical assistance aimed at eradicating the social issue of child marriage and violence against children across 12 districts (Deoghar, Dumka, Godda, Giridih, Garhwa, Hazaribagh, Jamtara, Koderma,

Pakur, Palamu, Sahibganj and W. Singhbhum) within Jharkhand. In this regard, a two-day orientation and induction at XISS, Ranchi on the 18 and 19, April 2024, as 12 District Project Coordinators – Child Protection (DPCs – CP) and one documentation officer assumed their roles to back the district's efforts in creating a better environment for every child's well-being.

### XISS & UNICEF Jharkhand join hands to strengthen child protection mechanisms in the state

## Panel discussion on Gender, Indigeneity, and Land Rights in Jharkhand

XISS, Ranchi and Indian Association for Women's Studies (IAWS) in collaboration with Women's Studies Centre, University Department of Economics, Ranchi University organised a Panel Discussion on 'Gender, Indigeneity and Land Rights in Jharkhand' at the Fr Michael Van den Bogaert SJ Auditorium in its campus.

Relevant issues of land alienation, erosion of community rights over lands, consequent displacement, migration, and poverty, and how they have impacted the lives of Adivasi women in significant ways were the topics on which the panelists laid emphasis during the sessions.

The 1908 Chotanagpur Tenancy Act (CNTA), 1949 Santhal Pargana Tenancy Act (SPTA), the LARR 2013 and the Panchayat Extension Schedule Act (PESA) 1996 were also discussed in detail during the discussion. The morning panel

discussion was led by Dr Vandana Tete, Dr Shalini Saboo, Roshan Horo, Dr Sunita Purty and, Dr Ramchandra Oraon. While Dr Shalini Saboo brought forth the legal perspectives on the debate on inheritance of land within Adivasi customary law, Vandana Tete on the other hand foregrounded the perspectives on land as an 'identity' and collective property within Adivasi world view.

The conveners of this panel discussion were Dr Ranjana Srivastava, Prof. In-charge, Jharkhand Women's Studies Project, IAWS, and Dr Jyoti Prakash, In-charge, Women's Studies Centre, University Department of Economics, Ranchi University. The coordinators were Amita Kumari, Convenor, Jharkhand Committee, IAWS, Dr Mamta Kumari, Coordinator, Women's Studies Centre, Arunopol Seal, Research Grantee at IAWS & Doctoral Fellow, University of Westminster, U.K, and Dr Pramil K. Panda, Assistant Professor, Rural Management Programme, XISS.
